Dear Ms. Dale:

On behalf of Missouri Gas Energy ("MGE"), I am providing herewith to the Missouri Public Service Commission ("Commission") for filing, in electronic form, certain tariff sheets consisting of revised rate schedules which are designed to increase MGE's gross annual revenues by approximately \$32,416,997, exclusive of applicable gross receipts, sales, franchise or occupational fees or taxes. The rate schedules bear a date of issue of April 2, 2009 and an effective date of May 2, 2009.

Also provided, in electronic form, is a letter from Michael R. Noack which sets forth a list of the rate schedules being provided, explains the purpose of the filing, and transmits certain information required by 4 CSR 240-3.030(3)(B) as well as the direct testimony and schedules of named MGE witnesses.


A copy of this entire filing will be provided to the Commission's General Counsel and to the Office of the Public Counsel.
