ORDER APPROVING EXPEDITED TARIFF

Issue Date: November 15, 2017

Effective Date: November 15, 2017

On September 27, 2017, the Commission issued an order granting Missouri-American Water Company (“MAWC”) a certificate of convenience and necessity to provide sewer services to the Homestead Estates subdivision, and authorized the Company to file new tariff sheets in compliance with that order. On November 9, 2017, MAWC filed substitute tariff sheets and a motion, *Motion for Expedited Treatment of Tariff Revisions*, requesting that the tariff sheets become effective on November 15, 2017. The tariff sheets carry an effective date of December 9, 2017, but the MAWC’s motion for expedited treatment asks the Commission to approve the compliance tariffs to take effect in less than thirty days’ notice to correspond with the sewer system acquisition.

The Commission ordered its Staff to file a recommendation by November 13, 2017, and also that any party wishing to respond to the MAWC’s motion or Staff’s recommendation do so no later than November 14, 2017. The Commission’s Staff timely filed its recommendation advising that the tariffs comply with the Commission’s order granting the certificate. Staff advises approval of the tariffs and does not object to expedited treatment. No other party has filed an objection or response regarding the motion for expedited treatment or the tariffs.

The Commission finds that the MAWC has demonstrated good cause to make the tariffs effective in less than thirty days' notice, since doing so avoids a gap where MAWC owns the Homestead Estates sewer system, but cannot legally operate it. Commission concludes that the submitted tariffs should be approved in less than thirty days' notice.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheets submitted under Substitute Tariff No. YS-2018-0059, as substituted, by Missouri-American Water Company are approved, effective on and after November 15, 2017. The specific tariff sheets approved are:
