**ORDER APPROVING TARIFF SHEETS IN COMPLIANCE
WITH COMMISSION ORDER**

Issue Date: October 18, 2021

Effective Date: November 3, 2021

On October 14, 2021, the Commission granted Elm Hills Utility Operating Company, Inc. (Elem Hills) a Certificate of Convenience and Necessity (CCN) to install, own, acquire, construct, operate, control, manage, and maintain a sewer system in Johnson County, Missouri, as an addition to its State Park Village service area. Staff recommended that Elm Hills submit the revised sewer tariff sheets containing the service area and legal description contained in Staff’s September 16, 2021 memorandum. Elm Hills filed tariff sheets on October 4, 2021, to revise the service area and legal description to conform to the service area in Staff’s memorandum. The Commission set a time for a Staff recommendation and any responses to the compliance tariff. Staff filed a recommendation that the Commission approve the tariff sheets, and no other responses were received.

After reviewing the tariff sheets and Staff’s recommendation, the Commission finds that Elm Hills’ tariff sheets comply with the Commission’s order and will approve them.

THE COMMISSION ORDERS THAT:

1. The tariff sheets filed on October 4, 2021, assigned Tariff No. YS-2022-0072, by Elm Hills are approved to become effective on November 3, 2021. The specific tariff sheets approved are:
