On December 6, 2022, Confluence Rivers Utility Operating Company, Inc., (Confluence) filed an application and motion for waiver seeking an order authorizing it to acquire certain utility assets in Cass County, granting it a Certificate of Convenience and Necessity, and granting a waiver of the notice requirements of Commission Rule 20 CSR 4240-4.017(1). On December 7, 2022, the Commission ordered the Commission's Staff (Staff) to file either a recommendation or a request for additional time no later than January 9, 2023.

On January 9, 2023, Staff filed a request for an additional sixty days to file a recommendation. Staff explains that it has promulgated data requests whose response deadlines fall after January 9, and that the holiday season and other scheduling issues prevented a site visit before January. The Commission finds Staff's request reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

- 1. Staff's request for additional time is granted.
- 2. Staff shall file its recommendation no later than Friday, March 10, 2023.
