ORDER GRANTING APPLICATIONS FOR INTERVENTION

On October 19, 1999, UtiliCorp United Inc. (UtiliCorp) and St. Joseph Light & Power Company (SJLP) filed a joint application with the Commission for authority to merge SJLP with and into UtiliCorp. On October 26, the Commission issued an Order and Notice that directed all interested parties to file an application to intervene no later than November 15. Timely applications requesting intervention were filed by AG Processing Inc. (AGP), the City of Springfield, Missouri, through the Board of Public Utilities (City Utilities), Union Electric Company, d/b/a AmerenUE (AmerenUE) and the Missouri Department of Natural Resources (MDNR).

The Commission has reviewed each of the applications to intervene and finds that each is in compliance with Commission rule 4 CSR 240-2.075(4). Each of the prospective intervenors has an interest in this matter that is different from that of the general public; City Utilities is a municipality; and granting each of the proposed interventions would serve the public interest. The Commission concludes that the

applications for intervention filed by AGP, City Utilities, AmerenUE and MDNR should be granted.

IT IS THEREFORE ORDERED:

1. That the Application to Intervene of AG Processing Inc. is granted.
2. That the Application to Intervene of the Missouri Department of Natural Resources is granted.
3. That the Application to Intervene of Union Electric Company d/b/a AmerenUE is granted.
4. That the Application to Intervene of the City of Springfield, Missouri, through the Board of Public Utilities is granted.
5. That this order shall become effective on November 29, 1999.
