ORDER RENEWING REGISTRATION AND DISMISSING DOCKET

On September 11, 1991, the Director of this Commission's Division of Manufactured Homes, Recreational Vehicles and Modular Units (Director) filed a complaint against R. E. Clark and Mercia Clark, Trustees of Piedmont Mobile Home Sales, Inc. (Respondents). On September 12, 1991, the Director filed an amended complaint against Respondents.

On September 30, 1991, Respondents filed an answer and notice of satisfaction to which the Director replied by a pleading filed October 4, 1991. The Director requests that the Commission find that the Respondents have completely satisfied all three of the counts contained in his complaint, approve the Respondents' offer of satisfaction and renew Respondents' registration.

In support of his request, the Director states that on September 23, 1991, the Respondents submitted to the Director a corporate certificate of good standing as proof that Respondent's corporate rights have been reinstated in this state and tendered to the Director for the Commission's approval a completed 1991 application for a certificate of registration accompanied by a renewal fee and supporting documents. The Director further states that on September 23, 1991, Respondents submitted to the Director documents indicating that corrective action had been taken

to bring the set-up of the Cowin home into compliance with the manufacturer's instructions. The set-up of the Cowin home is the subject of Count II. Finally, the Director states that on September 24, 1991, Respondents submitted to the Director copies of their monthly sales reports for the period of August, 1989 through December, 1989, in satisfaction of Count III of the Director's complaint.

Based upon the pleadings filed by the Director and the Respondents, the Commission finds that the Respondents have completely satisfied all three counts contained in the Director's complaint. Therefore, the Commission will dismiss this complaint and close this docket. Since the Respondents have also tendered their application for a certificate of registration for the year 1991, accompanied by a renewal fee and supporting documents, the Commission will renew Respondents' registration.

IT IS THEREFORE ORDERED:

- 1. That the satisfaction offered in this case by R. E. Clark and Mercia Clark, Trustees of Piedmont Mobile Home Sales, Inc., be approved hereby.
- 2. That the registration of Piedmont Mobile Home Sales, Inc., be renewed hereby.
 - 3. That this docket be closed hereby.
- 4. That this order shall become effective on the 25th day of October, 1991.
