ORDER SCHEDULING A SECOND WORKSHOP MEETING

The Commission opened this working case at the request of the Office of Public Counsel to consider a rule regarding the reporting of residential customer disconnection data. The Commission held an initial workshop meeting on November 18, 2020, to discuss such a rule. On December 7, 2021, Public Counsel filed a pleading including a revised draft rule for consideration. Public Counsel's pleading also asked the Commission to schedule a second workshop meeting in January 2022.¹ The Commission will do so.

THE COMMISSION ORDERS THAT:

1. A workshop meeting shall be held on Thursday, January 27, 2022, from 10:00 a.m. to 2:00 p.m. The meeting will be conducted virtually, on Webex. Anyone wishing to attend the meeting by Webex may do so by dialing 1-650-479-3207. The meeting number (access code) is 2463 447 6307, and the meeting password is 0148.

2. The Commission's data center shall provide a copy of this order to all Missouri investor-owned electric, gas, water, sewer, and steam heating utilities.

¹ Public Counsel's pleading requested that the meeting be held on January 25, but that date proved to be unworkable. Public Counsel has indicated that the revised date of January 27 will be acceptable to it and to the interested stakeholders.

3. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly, and to the news media serving the state of Missouri.

4. This order shall be effective when issued.
