



REQUEST FOR CANCELLATION OF PREHEARING CONFERENCE

AccuTel of Texas, Inc., (Applicant or AccuTel) requests that the Commission cancel the prehearing conference scheduled for Wednesday, March 8, 2000. On February 25, 2000, the Commission issued its Order Granting Intervention, Setting a Prehearing Conference and Directing Filing of Procedural Schedule. Southwestern Bell Telephone Company (SWBT) was granted intervention in the case. AccuTel anticipates negotiation of a Stipulation to resolve this matter, obviating the need for a prehearing conference and procedural schedule. The process of negotiating a Stipulation and Agreement should be completed in time for a Stipulation to be filed no later than the March 28, 2000, deadline for submission of a procedural schedule. Counsel for Staff and SWBT have indicated that they do not oppose AccuTel's request for cancellation or postponement of the prehearing conference.

WHEREFORE, Applicant respectfully requests the Commission cancel the prehearing conference scheduled in this matter.


