

KCPL RESPONSE TO STAFF RECOMMENDATION


COMES NOW Kansas City Power & Light Company ("KCPL"), and for its response to the Staff Recommendation filed by the Staff of the Missouri Public Service Commission's ("Staff") states as follows:

1. KCPL agrees to the Staff's recommended conditions of approval as stated in the Staff Recommendation and attached Staff Memorandum filed with the Missouri Public Service Commission ("Commission") on November 30, 2000.
2. KCPL hereby waives the 10-day effective date as to a Commission Order authorizing the issuance of up to \$400 million in debt securities, assuming the Commission approves KCPL's Amended Application.

WHEREFORE, KCPL requests the Commission enter an Order containing the authorization requested in Paragraph 19 of KCPL's Amended Application and Motion for Expedited Treatment filed with the Commission on November 2, 2000.


