**MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through the undersigned counsel, and moves for the Commission to cancel the certificate of service authority of FSH Communications, L.L.C. ("FSH Communications" or "Company"). For its Motion, Staff respectfully states as follows:

1. On September 25, 2006, the Commission issued an order granting a certificate of service authority to the Company to provide private pay telephone services in the state of Missouri in Case No. PA-2007-0094.

2. On April 15, 2014, the Commission received a letter from FSH Communications requesting the withdrawal of its certificate of authority to provide public pay phone service in the State of Missouri. (BCES-2014-1655) (See Attachment A).

3. Because FSH Communications is ceasing its operations in Missouri, Staff recommends the Commission cancel its certificate of service authority.

4. The Commission has the authority to cancel this certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

**WHEREFORE**, Staff recommends the Commission cancel the certificate of service authority of FSH Communications, L.L.C., to provide private pay telephone services in the State of Missouri.
