ORDER ESTABLISHING TIME TO RESPOND

On August 12, 2021, the Staff of the Public Service Commission filed a motion advising the Commission to cancel the certificate of service authority to provide private payphone telephone service of Missouri Telephone and Telegraph, Inc. at that company's request. The Commission granted Missouri Telephone and Telegraph a certificate to provide payphone service on January 31, 1995, in Case No. TA-95-185.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's recommendation and the company's request.

The Commission finds that proper persons shall be allowed 10 days to file a motion for hearing.

THE COMMISSION ORDERS THAT:

1. Anyone wishing to respond to Staff's recommendation or request a hearing shall do so by filing an appropriate pleading no later than August 23, 2021.
2. This order shall be effective when issued.
