### ORDER SCHEDULING HEARING

On August 3, 2000, the Staff of the Missouri Public Service Commission (Staff) on behalf of the City of Wentzville, Missouri, the Public Water Supply District No. 2 of St. Charles County, Missouri, and the Office of the Public Counsel, filed a proposed procedural schedule.
