ATMOS ENERGY CORPORATION'S MONTHLY STATUS REPORT ON COLLABORATIVE PROCESS MAY 1, 2007

COMES NOW Atmos Energy Corporation ("Atmos"), pursuant to the Commission's *Report and Order* ("*Order*") issued in this matter on February 22, and effective March 4, 2007, and for its second Status Report on Collaborative Process, respectfully states as follows:

1. Since the first collaborative meeting regarding Atmos' energy efficiency and conservation program held on March 22, 2007 in Jefferson City, Missouri, 1 two collaborative meetings conducted via conference calls were held on April 4 and April 19, 2007, respectively, with the next conference call scheduled to take place on May 3, 2007. Each of the entities participating in this collaborative process were represented on the conference calls, which includes Atmos, the Commission Staff, the Office of the Public Counsel and the Missouri Department of Natural Resources – Energy Center. In addition, the representatives of Atmos also conducted a call with representatives from AmerenUE and Missouri Gas Energy to gather information concerning the administration and/or progress of their conservation programs.

2. Building on the positive contributions of the various participants as referenced in the first Status Report, much fruitful discussion and research have continued to date. In fact, the parties appear to have reached a general consensus concerning the framework/design of the proposed program, including the components and associated contribution amounts. Reflecting this work product, Atmos is preparing a draft tariff for participants to review and discuss on the May 3rd conference call. Atmos respectfully submits that the collaborative process has proven to be very productive thus far; however, there will be a great deal of work involved to implement this program by the August 31, 2007 date set forth in the Commission's Report and Order. Therefore, Atmos will continue to make every effort to expedite this process in order to present the program to the Commission as much in advance of the June 30, 2007 date, set by the Commission, as possible.
