**MOTION TO CONSOLIDATE**

COMES NOW Silverleaf Resorts, Inc. (Silverleaf) and Algonquin Water Resources of Missouri, LLC (Algonquin), and, as their motion to consolidate, states as follows to the Missouri Public Service Commission (Commission):

1. Silverleaf and Algonquin have filed with the Commission a Joint Application seeking permission for Algonquin to acquire both the water and sewer assets of Silverleaf located in Missouri. Two case numbers have resulted from the filing of this Joint Application (WO-2005-0206 and SO-2005-0207).


2. The proposed purchase of the water and sewer assets is a single transaction governed by a single agreement.

3. Accordingly, there are common questions of law and fact in the above-referenced cases and the consolidation of Cases Nos. WO-2005-0206 and SO-2005-0207 would be administratively expedient in that it would simplify the filings to be made.

WHEREFORE, Silverleaf and Algonquin request a Commission order consolidating Cases

Nos. WO-2005-0206 and SO-2005-0207, with Case No. WO-2005-0206 being the lead case.
