**Report on Mediation**

COMES NOW the Director of the Department of Manufactured Homes and Modular Units of the Public Service Commission ("Director" and "Department"), by and through the Missouri Public Service Commission's ("Commission") Office of General Counsel, and for his Report on Mediation states as follows:


1. On March 27, 2000, the Respondent filed a Request for Voluntary Mediation. On March 28, 2000, the Director filed a response stating that he had no objections to, and was willing to submit to, voluntary mediation. On March 30, 2000, the Commission issued its Order Directing Mediation.

2. Counsel for the Director and Counsel for the Respondent have been discussing various issues and had scheduled a meeting to resolve the Complaint based on those discussions. However, due to the flooding which recently occurred in Union, Missouri, and the need for the Director and his staff to perform multiple inspections in the days immediately following the flood, the meeting was canceled. This has delayed resolution of the case.

3. The parties are in ongoing discussions and expect to reach an agreement to settle this case. The Director will file an update on these discussions on August 1, 2000.


