On September 27, 2016, Osage Water Company filed a Response to Staff's Status Report. Osage Water Company's Response included professional reports that evaluated the estimated costs of expanding water and sewer services to undeveloped lots in the Eagle Woods Subdivision. The Commission's October 22, 2015, Report and Order also directed Osage Water Company to seek clarification from the appropriate circuit court on whether the court-appointed receiver is authorized to take the necessary steps to connect the twenty-five lots in the Eagle Woods Subdivision. The Commission will direct the company to submit a status report on the circuit court's determination.
