Request To Postpone Prehearing Conference

COMES NOW the Director of the Department of Manufactured Homes and Modular Units of the Public Service Commission ("Director" and "Department"), by and through the Missouri Public Service Commission's ("Commission") Office of General Counsel, and for his Request to Postpone the Prehearing Conference, states as follows:

- 1. On March 17, 2000, the Commission issued an Order establishing a prehearing conference in the above-captioned case to be held on April 19, 2000. The prehearing conference was then rescheduled to April 25, 2000 at the request of the parties.
- 2. The Director and the Respondent have reached an agreement in principle that would settle this case. Therefore, it is requested that the prehearing conference be postponed until June 6, 2000 to allow the parties to work out the details of this agreement and possibly eliminate the need for the prehearing conference.
 - 3. All counsel of record have been contacted and there is no objection to the delay.
- 4. If the Commission approves this delay, the Director also requests that the filing of the proposed procedural schedule be rescheduled for June 13, 2000.

WHEREFORE, the Director respectfully requests that the Commission postpone the prehearing conference until June 6, 2000 and order that the proposed procedural schedule be filed on June 13, 2000.
