On June 8, 2016, the Commission issued an order opening a working file to determine whether the Commission's ex parte and extra-record communications rule should be amended. The Commission established a deadline of August 22, 2016 for interested persons or entities to comment or respond to those proposed rule amendments. The Commission will provide an opportunity for persons or entities to reply to any filed comments or to provide supplemental comments to those previously filed.

### THE COMMISSION ORDERS THAT:

1. Any person or entity wishing to reply to any comments filed in this matter or to provide supplemental comments to those previously filed shall do so no later than October 6, 2016.
2. This order shall be effective when issued.


