- 1. Beginning March 25, 2005¹ and continuing through September 2, the Staff has made weekly filings in this case that have included information regarding the following matters: (a) the status of the potential transfer of Mill Creek Sewers, Inc.'s (Mill Creek) sewage treatment and collection system to the St. Louis Metropolitan Sewer District, or another entity (now including Missouri-American Water Company in addition to a non-profit entity formed by Mill Creek's customers); (b) the Staff's on-going monitoring of the condition and operation of Mill Creek's sewage treatment plant; (c) the actions taken by Mill Creek in response to issues brought to its attention as a result of the Staff's monitoring of the sewage treatment plant; and (d) Mill Creek's response to a Department of Natural Resources' (DNR) report regarding a joint DNR/Staff inspection of the sewage treatment plant.
- 2. On September 9, the Staff filed its <u>Supplemental Recommendation for Approval</u> of Tariff Revisions (Supplemental Recommendation) in this case.
- 3. As a result of the filing of the Staff's Supplemental Recommendation, the discussion of this case during the Commission's September 15, agenda session, and the
