ORDER CANCELING PRIVATE PAY TELEPHONE CERTIFICATES

Issue Date: June 29, 2006

Effective Date: July 9, 2006

This order cancels the private pay telephone certificates of Alan Ray Felten; Nathan Veach; Jim Ecton d/b/a JSE Enterprises; Catherine A. Ragland; Desh V. Anand; John B. Degraffenreid; Thomas Parr; and Todd R. Prother (hereinafter collectively referred to as "Providers").

On May 23, 2006, the Staff of the Missouri Public Service Commission filed a motion requesting that the Providers' certificates to provide private pay telephone service be canceled. Staff alleges each of the Providers has returned a statement of revenue for the fiscal year 2005 assessment, reporting \$0 annual revenue. Each of the Provider's 2005 statement of revenue forms indicated that

the Providers no longer provide service and wish to have their authority canceled. The Providers owe no assessments to the Commission. None of the Providers has filed a response to Staff's motion.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and the Providers' requests to cancel the certificates included in their 2005 statements of revenue, the Commission finds that the private payphone certificates granted to each of the Providers shall be canceled.

IT IS ORDERED THAT:

1. The private payphone certificate granted to Alan Ray Felten, in Case Number TA-96-215, is canceled.
2. The private payphone certificate granted to Nathan Veach, in Case Number PA-2005-0225, is canceled.
3. The private payphone certificate granted to Jim Ecton d/b/a JSE Enterprises, in Case Number PA-2005-0032, is canceled.
4. The private payphone certificate granted to Catherine A. Ragland, in Case Number PA-2004-0615, is canceled.
5. The private payphone certificate granted to Desh V. Anand, in Case Number PA-2005-0082, is canceled.

6. The private payphone certificate granted to John B. Degraffenreid, in Case Number TA-2001-105, is canceled.

7. The private payphone certificate granted to Thomas Parr, in Case Number TA-98-228, is canceled.

8. The private payphone certificate granted to Todd R. Prother, in Case Number PA-2004-0612, is canceled.

9. This order shall become effective on July 9, 2006.

10. This case may be closed on July 10, 2006.
