The Commission has undertaken this rulemaking to create a new rule to provide parameters and procedures for small water or sewer utilities or both to request a special fund to collect revenues from customers to make improvements necessitated by environmental regulations. The Commission finds that the promulgation of a new rule is necessary to protect the public interest and to carry out the purposes of the statute that granted the Commission authority to regulate in this area.

The Commission will seek comments from interested stakeholders during the rulemaking process.

THE COMMISSION ORDERS THAT:

1. The Secretary of the Commission shall file the proposed rule with the Secretary of State for publication in the Missouri Register.

2. This order shall be effective when issued.
