## **ORDER CANCELING CERTIFICATE**

Issue Date: January 5, 2012

Effective Date: January 15, 2012

On December 20, 2011, the Staff of the Missouri Public Service Commission filed a motion requesting Telecor Communications, Inc.'s certificate of service authority to provide private pay telephone services in the State of Missouri be cancelled.

In File Number TA-98-558, the Commission granted Telecor a certificate of service authority to provide private pay telephone service in the State of Missouri.

Staff states in its motion that on February 19, 2004, the Missouri Secretary of State's Office (SOS) revoked Telecor's authority to do business in the state of Missouri for failure to file an annual report. On November 18, 2011, Telecor notified the Commission that the company is no longer doing business in Missouri. Staff recommends that the Commission cancel Telecor's certificate of service authority to provide private pay telephone service.

On December 21, 2011, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than January 3, 2012. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority granted to Telecor Communications, Inc., shall be canceled.

**IT IS ORDERED THAT:**

1. The certificate of authority to provide private pay telephone services granted to Telecor Communications, Inc., in File Number TA-98-558, is canceled.
2. This order shall become effective on January 15, 2012.
3. This case may be closed on January 16, 2012.


