**RE: Case No. GR-2013-????, Missouri Gas Energy**

Attached for filing on behalf of Missouri Gas Energy is an electronic version of P.S.C. MO. No. 1, Twenty-Eighth Revised Sheet No. 24.3, canceling Twenty-Seventh Revised Sheet No. 24.3. This tariff sheet bears an issue date of March 15, 2013, and a proposed effective date of April 1, 2013.

By this filing, MGE proposes to make an adjustment to the Purchased Gas Adjustment (PGA) Rate as permitted under the provisions of Sheet No. 15 of MGE's tariff. MGE is proposing to adjust the Current Cost of Gas Factor (C.C.G.).

The proposed PGA Rate of \$0.56529 reflects a decrease of \$0.03941 per Ccf over the PGA Rate currently in effect of \$0.60470. The change in the PGA Rate reflects a decrease in the C.C.G. Factor of \$0.03941 per Ccf, from the current C.C.G Factor of \$0.55910 to the proposed amount of \$0.51969.

The proposed adjustment has the overall net effect of decreasing revenues in MGE's service area by approximately \$22,111,798 annually. This represents an overall 6.52% decrease in revenues.

Workpapers supporting the calculations performed in developing the proposed changes have been provided this date under a separate cover letter to the Commission's Staff and The Office of the Public Counsel.


