**REQUEST FOR EXTENSION OF TIME**

**COMES NOW**, Union Electric Company d/b/a AmerenUE (“Company”) for an Order from requesting the Missouri Public Service Commission (“Commission”) that extends the time to implement the transfer Girardeau Stevedores Contractors’ (“GSC”) electric service from SEMO Electric Cooperative (“SEMO”) to Company and Company states as follows:

1. Case No. EO-2006-0145 involves the application by GSC for Commission approval a change of electric service provider from SEMO to Company. In its Order Approving Stipulation And Agreement issued on January 24, 2006 (the “Order”), the Commission approved the transfer of electric service and stated “...AmerenUE shall coordinate and implement the change of supplier in no less than 30 and no more than 60 days from the date this order is issued.”

2. The time period in the Order to coordinate and implement the change of supplier has expired. The Company could not implement the change because GSC has not completed its internal 3-phase wiring necessary to accept 3-phase service from Company. This work is ongoing but it is not expected to be completed for some time.

3. To permit the completion of GSC’s internal wiring effort and allow sufficient time for SEMO and Company to the transfer the electric service, Company respectfully requests that the Commission issue an order extending the time to coordinate and implement this change of supplier until June 30, 2006.


