
REQUEST FOR WAIVER

COMES NOW City of Farmington, Missouri, by and through counsel, R. Scott Reid of Schnapp, Fall, Silvey, Reid & Bollinger, LLC, and for its Request for Waiver, states to the Commission as follows:

1. When Applicant filed its initial Application for Change of Service Provider, it did not file the Notice required by 4 C.S.R. 240-4.017(1).
2. Good cause exists to waive the requirement of filing the 4 C.S.R. 240-4.017(1) Notice sixty (60) days prior to the filing of this case for the reason that the City of Farmington has had no communication with the Office of the Commission within the prior 150 days from the date the Application was filed regarding any substitutive issue likely to be in this case. Good cause exists to waive the 60-day notice required under 4 C.S.R. 240-4.017(1).
3. Attached hereto is a verified Declaration of Greg Beaver, City Administrator for the City of Farmington.

WHEREFORE, Applicant prays for the Commission's Order waiving the Notice filing requirement under 4 C.S.R. 240-4.017(1), and grant Applicant such other and further relief as the Commission deems just and appropriate under the circumstances.


