

REQUEST FOR RECONSIDERATION


COMES NOW the Telecommunications Resellers Association (TRA) and for its Request for Reconsideration, states as follows:

1. In its Order Granting Interventions and Modifying Procedural Schedule issued December 30, 1998, the Commission denied TRA's intervention, but authorized TRA to request reconsideration of its Application.

2. TRA has determined that its interest in this matter is limited to monitoring the proceedings and filing a post-hearing brief, which more appropriately calls for status of participation without intervention pursuant to 4 CSR 240-2.075(5) rather than full intervention. TRA understands 4 CRS 240-2.075(3) does not apply to requests to participate without intervention. TRA was granted participation without intervention in Case No. TO-97-56.

WHEREFORE, TRA requests that in reconsidering TRA's Application, the Commission now grant it participation without intervention in this docket.


