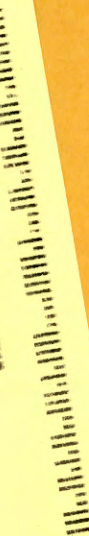

On December 12, 2011, the Staff of the Missouri Public Service Commission ("Staff") filed a motion requesting that the Commission cancel the certificate of service authority of Sterling Payphones, LLC ("Sterling"). Sterling holds a certificate of service authority to provide private pay telephone service in the State of Missouri via customer-owned coin telephone equipment. The Commission will allow Sterling to respond to the Staff's motion. If Sterling fails to respond, the Commission may grant the Staff relief by default.

THE COMMISSION ORDERS THAT:

1. Sterling Payphones, LLC may respond to the Staff's Motion to Cancel Certificate of Service Authority no later than December 23, 2011.

2. This order shall become effective immediately upon issuance.


