On May 5, 2018, Robidoux Ringtone, L.L.C. (“Robidoux”) filed a letter surrendering its certificate of service authority.

In Case Number PA-2013-0474, the Commission granted Robidoux a certificate to provide private pay telecommunications services.

The Commission will direct its Staff to review the request and file a recommendation regarding the surrender of Robidoux's certificate of service authority.

IT IS ORDERED THAT:

1. No later than May 21, 2018, the Staff of the Missouri Public Service Commission shall file a recommendation regarding Robidoux Ringtone, L.L.C.'s request to surrender its certificate of service authority.

2. This order shall be effective when issued.

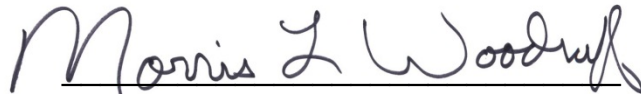
