Accompanying this letter for filing via the Commission's Electronic Filing and Information System (EFIS) are revised tariff sheets, which are designed to increase AmerenUE's gross annual electric revenues by approximately \$401.5 million, exclusive of applicable gross receipts, sales, franchise or occupational fees or taxes. Included in this increase is approximately \$227 million of anticipated increases in normalized net fuel costs above the net fuel costs included in base rates in the Company's last general rate proceeding.
