STAFF'S POSITION STATEMENTS

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and states its position on the issues filed in the *List of Issues* as follows:

1. <u>Availability Fees</u>

a. Should charges for availability fees collected from owners of undeveloped lots in LRWS's service territory and billed and retained by an affiliate company be classified as LRWS revenue or applied against rate base?

Yes, fees collected for the availability of water and/or sewer services from an affiliate company are revenue and should be included in the general revenue requirement for the Lake Region Water & Sewer System.

b. If the Commission finds charges for availability fees of undeveloped lots are not to be classified as LRWS revenue, or applied against rate base, then what costs should be identified and excluded from LRWS's cost of service?

If the availability fees are excluded, then those costs associated with availability fees should be excluded from rates. The availability fee costs should be allocated to Lake Utility Availability 1.

2. <u>Executive Management Compensation/Management Fees</u>

a. What is the appropriate level of executive management compensation to be included in LRWS's revenue requirement for setting LRWS's rates?

An appropriate level of executive management compensation for services provided to the utilities by the management/ownership group (Robert Schwermann, Brian Schwermann and Vernon Stump), per Staff's last EMS run is approximately \$27,901 – allocated between the three operating systems of Shawnee Bend Water \$7,115, Shawnee Bend Sewer \$7,477 and Horseshoe Bend Sewer \$13,309 – and should be included in LRWS's cost of service.
