**AMEREN MISSOURI'S RESPONSE TO
RECOMMENDED REPORT AND ORDER**

COMES NOW Union Electric Company, d/b/a Ameren Missouri ("the Company") and for its Response to Recommended Report and Order respectfully states as follows:

1. On March 24, 2014, Senior Regulatory Law Judge Jordan issued his Recommended Report and Order in this case.
2. On March 27, 2014, the Staff of the Missouri Public Service Commission ("Staff") filed their response to the Recommended Report and Order.
3. The Company supports the corrections/clarifications outlined in Staff's Response.
4. After review of the Recommended Report and Order, the Company offers an additional correction and a clarification.
5. First, paragraph 5 on page 13 refers to the energy assistance grant in the amount of \$192 which appeared as a charge on Mr. Mershon's bills. The Company suggests this paragraph be changed to read "Also in January 2013, Mr. Mershon was eligible for an energy assistance grant *to cover accrued charges* in the amount of \$192 *and the charge continued to appear* on Mr. Mershon's bills until Ameren received the *grant* amount in full."
6. Second, paragraph 10 on page 15 states that the Company received a \$40 payment on May 7, 2013. As reflected in EFIS No. 104, Ameren Exhibit 1HC, p. 5, payment was actually made on May 20, 2013.

WHEREFORE, Ameren Missouri respectfully submits this Response to the Recommended Report and Order and requests that the items set out above be corrected or clarified before the Report and Order is finally approved.
