

**MOTION FOR EXTENSION OF TIME**

COMES NOW the Staff ("Staff") of the Public Service Commission of Missouri ("Commission") and for its motion for extension of time states as follows:


1. Apparently the Commission issued an order in this docket yesterday, March 29, 2001, directing Staff to file, not later than today, its recommendation on the tariff filed by Laclede Gas Company ("Laclede") on March 26, 2001, in compliance with a Commission order dated February 13, 2001. Counsel for Staff has not yet (2:340 p.m. on March 30) received a copy of said order.
2. The Staff and Laclede have reached an agreement in principle concerning tariff language to comply with the Commission's order. Staff expects that when the parties have agreed on the new tariff language, that Laclede will withdraw the March 26 tariff filing and substitute the agreed upon language. Staff and Laclede have not yet had time to consult with the Office of the Public Counsel, but will do so before the close of business today.

WHEREFORE, Staff moves for an extension of time until Wednesday, April 4, 2001, to either file its recommendation on the substituted tariff, or file its recommendation on the current proposed tariff language.


