LACLEDE GAS COMPANY'S MOTION FOR RELIEF FROM PARAGRAPH 2 OF THE COMMISSION'S DECEMBER 13, 2007 ORDER AND MOTION TO CLOSE CASE

COMES NOW Laclede Gas Company ("Laclede" or "Company"), on behalf of itself, Complainant Lynne P. Shewmaker ("Ms. Shewmaker") and the Staff of the Missouri Public Service Commission ("Staff"), and submits this Motion for Relief from Paragraph 2 of the Commission's December 13, 2007 Order and Motion to Close Case, and in support thereof states as follows:

- 1. On December 13, 2007, the Commission issued its Order Granting Relief from Portion of Report and Order (the "December 13 Order"), in which the Commission relieved Staff of the obligation to test the meter at Ms. Shewmaker's home and instead required Laclede to perform the meter test. Following issuance of the December 13 Order the parties worked out acceptable terms to remove, test and re-install the meter in January 2008.
- 2. However, on January 2, 2008, Ms. Shewmaker sent an email to Staff and Laclede informing them that, during the holidays, she and Mr. Shewmaker had discussed this matter and preferred to bring it to an immediate conclusion. Ms. Shewmaker stated that, rather than expend further time and energy on another meter change, they had

decided to keep the meter and AMR module as is. On January 3, 2008, Ms. Shewmaker sent emails to both Staff and Laclede confirming her decision to bring the matter to a close without further action. These emails stated as follows:

Mr. Zucker,

I confirm your email of today's date that you are proceeding to conclude this matter after my decision not to proceed with the change out and testing of the meter originally set for tomorrow's date.

Please let me know if any documentation is required to be signed.

Thank you.

Lynne Shewmaker

Ms. Fred,

I accept that your email of today's date suffices as proof of my decision to retain the existing meter and not proceed with change out and checking.

Thank you.

It is Ms. Shewmaker's desire that these confirmations will permit her to conclude this matter without further involvement. However, she has expressed her willingness to provide further confirmation in writing to the Commission, if the Commission so orders.

3. Based on the customer's clearly stated wishes, the parties request that the Commission relieve them of all obligations required in Paragraph 2 of the December 13 order and close this case.

WHEREFORE, Laclede respectfully requests, on behalf of itself, Ms. Shewmaker and Staff, that the Commission relieve the parties from all obligations set forth in paragraph 2 of the December 13 Order and close this case.
