ORDER GRANTING MOTION FOR EXPEDITED TREATMENT AND APPROVING TARIFFS IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: October 13, 2017 Effective Date: October 17, 2017

On October 6, 2017, Elm Hills Utility Operating Company, Inc. ("Elm Hills") submitted tariff sheets (Tracking Nos. YS-2018-0038 and YW-2018-0037) to comply with the Commission's September 19, 2017 *Order Approving Stipulation and Agreement, Granting CCN and Transfer of Assets.* In addition to seeking approval of the tariff sheets, Elm Hills filed a motion requesting expedited treatment so the tariff sheets can go into effect on October 17, 2017. As an explanation for the request, Elm Hills states that it intends to complete the Commission-approved transfer of assets on October 16, 2017.

The Commission issued an order directing the Commission's Staff to file a recommendation on Elm Hill's tariff sheets no later than October 11, 2017. The Commission also set an October 12, 2017 deadline for the filing of responses to Elm Hills motion for expedited treatment or objections to Elm Hill's tariff sheets. Staff submitted a timely recommendation to approve the tariff sheets. Staff states that Elm Hills' tariff sheets comply with the terms of the *Nonunanimous Stipulation and Agreement* that was approved by the Commission. Staff also states that it supports Elm Hills's *Motion for Expedited Treatment*. No other responses were filed.

Upon review of the pleadings, the Commission finds that Elm Hills's tariff sheets comply with the Commission's September 19, 2017 order, and will therefore approve them. Furthermore, the Commission finds that good cause exists for the tariffs to become effective in less than thirty days. For this reason, the Commission will approve the tariffs becoming effective on October 17, 2017.

THE COMMISSION ORDERS THAT:

- The tariff sheets filed by Elm Hills Utility Operating Company, Inc. on October
 2017, and assigned Tracking No: YS-2018-0038, are approved to become effective on October 17, 2017.
- 2. The tariff sheets filed by Elm Hills Utility Operating Company, Inc. on October 6, 2017, and assigned Tracking No: YW-2018-0037, are approved to become effective on October 17, 2017.
 - 3. This order shall become effective on October 17, 2017.
