On October 9, 2017 Highway H Utilities, Inc. filed its *Application and Motion for Waiver* seeking authority to sell certain water and wastewater system assets to the City of Waynesville, Missouri and Pulaski County Sewer District Number 1. The Commission published notice of the application and set a November 9, 2017, deadline for interested persons to request intervention. No applications to intervene have been filed.

The Commission's Staff was ordered to file a pleading indicating a date when it would file a recommendation; Staff's pleading stated that they anticipate filing a recommendation by January 8, 2018. The Commission will establish that date for Staff to file its recommendation.

THE COMMISSION ORDERS THAT:

1. No later than January 8, 2018, the Staff of the Commission shall file its recommendation regarding this application.

2. This order shall be effective when issued.


