ORDER DIRECTING NOTICE AND ORDER DIRECTING FILING

On November 14, 2017, Jefferson County Public Sewer District and Utility Management of Missouri, LLC, as the court-appointed receiver of P.C.B., Inc., filed a joint application¹ with the Missouri Public Service Commission ("Commission") seeking an order authorizing the sale, transfer, and assignment of assets relating to sewer services provided to customers in the Bel Air Estates, Secluded Forest Subdivision, Wedgewood Village, Sennawood Village, and Sandia Heights areas in Jefferson County, Missouri.

Section 393.190.1, RSMo 2016, requires that when transactions such as the one described in the application are submitted to the Commission for approval, the Commission must send notice "to the county clerk of each county in which any portion of a political subdivision which will be affected by such disposition is located." Since the application states that the sewer facilities being sold are located in Jefferson County,

Missouri, the Commission will direct its Data Center to send a copy of this order to the county clerk and county commission of Jefferson County and will direct notice to the representatives and news media serving residents of that county. The Commission will also establish deadlines for persons wishing to intervene and a preliminary response from its Staff.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send a copy of this order to the county clerk and county commission of Jefferson County, Missouri.
2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing the residents of Jefferson County, Missouri, and to the news media serving the residents of Jefferson County.
3. Any interested person wishing to intervene in this case shall file an application to intervene no later than December 6, 2017.
4. No later than December 6, 2017, the Staff of the Missouri Public Service Commission shall file a pleading stating when it anticipates filing its recommendation in this matter.
5. This order shall become effective when issued.
