

REQUEST FOR LEAVE TO FILE OPPOSITION OF OPERATING ENGINEERS LOCAL 148 TO JOINT MOTION TO OPPOSE INTERVENTION WITH ALL PAGES

Comes now Intervenor-Applicant International Union of Operating Engineers Local No. 148, AFL-CIO ("OE Local 148"), and respectfully requests leave to file the enclosed Opposition Of Operating Engineers Local 148 To Joint Motion To Oppose Intervention (the "Opposition") containing all pages. In support of this request, Local 148 states as follows:

1. OE Local 148 timely filed its Opposition with the Public Service

Commission (the "Commission") on November 5, 2001. At the same time, IntervenorApplicant International Brotherhood of Electrical Workers Local 1455, AFL-CIO

("IBEW Local 1455") also filed its Opposition of International Brotherhood of Electrical

Workers Local 1455 To Joint Motion To Oppose Intervention (the "IBEW Opposition").

OE Local 148's Opposition and the IBEW Opposition were intended to be virtually identical.

- 2. On November 8, 2001, the undersigned discovered for the first time that due to a printing or copying error, the original and at lest some of the copies of OE Local 148's Opposition were filed with the Commission without pages 6, 7, and 8. The undersigned does not know whether or not the copies of OE Local 148's Opposition served on other parties in the case contained pages 6, 7, and 8.
- 3. The IBEW Opposition contained pages 6, 7, and 8, including virtually all the argument contained on the missing pages 6, 7, and 8 from OE Local 148's Opposition.
- 4. OE Local 148 seeks here to file its Opposition containing pages 6, 7, and 8. The enclosed document, styled "Opposition Of Engineers Local 148 To Joint Motion To Oppose Intervention (Complete), contains the missing pages 6, 7, and 8.
- 5. Granting leave to file the complete Opposition at this time will not hinder or delay this proceeding or prejudice any party because: (a) the deadline to apply to intervene here is not until November 26, 2001, and (b) all parties had timely notice of the unions' complete argument from the IBEW Opposition.
- 6. Since the undersigned does not know whether the service copies of OE Local 148's Opposition contained pages 6, 7, and 8, copies of the enclosed complete document are being sent to all parties of record.

WHEREFORE, OE Local 148 respectfully requests leave to file the enclosed Opposition Of Operating Engineers Local 148 To Joint Motion To Oppose Intervention (Complete) with pages 6, 7, and 8.
