**STAFF'S MOTION FOR FURTHER EXTENSION  
OF TIME TO FILE INCIDENT REPORT**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and, in response to the Missouri Public Service Commission's November 21, 2007 *Order Extending Time to File Report*, states:

1.     The Commission issued its *Order Extending Time to File Report* in response to the Staff's request that it not be required to file either a final report or incident report no later than November 30, 2007, on the basis of statements made to the Staff that Kansas City Power & Light Company (KCPL) planned to complete by December 7, 2007 its final report on the May 9, 2007, superheater attemperator spray water pipe failure at the Iatan Generating Station which KCPL operates near Weston, Missouri, that caused the deaths of two KCPL employees and critically injured another; KCPL was to make its response to OSHA's citations by November 28, 2007; and that KCPL retained an outside consultant develop a flow accelerated corrosion monitoring program for which KCPL executive approval is not expected before December 31, 2007.

2.     Unfortunately, events have not transpired as anticipated. The Staff did not receive KCPL's final investigation report until January 18, 2008. The Staff did not receive KCPL's new FAC monitoring program guideline, approved by its corporate officers, until January 23, 2008. Further, the Staff is informed OSHA has requested of KCPL and obtained an extension to

respond to KCPL's Notice of Contest to OSHA's citations, and that OSHA's response to KCPL is expected to be made by January 31, 2008.

3. The Staff will file a final report on this incident by March 17, 2008 and, if necessary, supplement that report later.

WHEREFORE, the Staff requests the Commission grant the Staff a further extension until March 17, 2008 to file the Staff's final report.
