REQUEST TO TAKE OFFICIAL NOTICE

COMES NOW Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”) and, pursuant to Section 536.070(6), hereby requests that the Commission take official notice of the following documents, all of which are directly relevant to the question of what the proper sharing percentage in Ameren Missouri’s Fuel Adjustment Clause (“FAC”) should be:¹
