ORDER OF PARTIAL DISMISSAL AND
DIRECTING ADDITIONAL CALLING STUDY

The Commission has received a petition signed by residents of the
Lucerne exchange requesting extra-exchange calling at less than toll rates from
the Lucerne exchange served by Grand River Mutual Telephone Company to the
Unionville exchange served by GTE North and to the Lemons exchange served by
Northeast Missouri Rural Telephone Company.

By order issued May 29, 1991, the Commission directed Grand River
Mutual Telephone Company to perform a calling usage study covering one billing
cycle in order to ascertain whether a sufficient community of interest exists
between these exchanges to justify providing them with community optional service
(COS).

On September 16, 1991, Grand River Mutual Telephone Company filed the
results of the calling usage study performed in said exchanges. The results of
said study are as follows:

In its Report and Order issued in Case No. TO-87-131, the Commission found that a community of interest would be demonstrated if a calling usage study showed that six calls per access line per month are made on the average from the petitioning exchange to the requested exchange and two-thirds of the customers in the petitioning exchange make two or more calls per month to the requested exchange. *In re the investigation of experimental extended measured service (EMS)*, 30 Mo. P.S.C. (N.S.) 45 (1990).

Since the Lucerne to Lemons route did not demonstrate a sufficient community of interest, the Commission determines the petition for that route should be dismissed. Since the Lucerne to Unionville route passed the calls per access line criterion and was extremely close to the two calls per month criterion, the Commission determines that a new calling study should be conducted for this route.

Even though the petition for the Lucerne to Lemons route has been dismissed, customers in those exchanges may still be provided expanded calling through a statewide expanded calling scope plan currently under consideration by the Commission in Case No. TO-92-306. The plan under consideration would implement a Metropolitan Calling Area (MCA) service in St. Louis, Kansas City and Springfield. The MCA service modifies and expands the Wide Area Service Plan currently in place in St. Louis and Kansas City. The plan being considered by the Commission would also provide an Outstate Calling Area (OCA) service for those exchanges not included in an MCA. The OCA service would be an optional service offered for expanded calling beyond a customer's local exchange. The Commission is considering two alternatives for the scope of the OCA: a 23-mile radius from each exchange's central office or a 23-mile multipoint service measured from central office to central office.

IT IS THEREFORE ORDERED:

1. That the petition for community optional service from Grand River Mutual Telephone Company's Lucerne exchange to Northeast Missouri Rural Telephone Company's Lemons exchange is hereby dismissed.

2. That Grand River Mutual Telephone Company shall perform a calling study covering one billing cycle for the traffic from the Lucerne exchange to GTE North's Unionville exchange.

3. That the results of the calling study herein ordered shall be filed within one hundred twenty (120) days from the effective date of this order.

4. That this order shall become effective on September 1, 1992.
