**MOTION TO MODIFY PROCEDURAL SCHEDULE**

**COMES NOW** the Office of the Public Counsel (“OPC”) and for its *Motion to Modify Procedural Schedule*, states as follows:

1. The OPC filed a request to modify the procedural schedule in this case on January 22, 2021, due to a medical emergency that prevented it from timely filing rebuttal testimony.
2. The Commission granted the OPC’s request to modify the procedural schedule the same day.
3. Due to the continuing nature of the medical emergency, the OPC has subsequently determined that one additional week will be necessary to meet its deadline to file rebuttal testimony.
4. The OPC has once again sought, and all parties to this case have once again graciously agreed, to modify the procedural schedule.
5. The OPC proposes the following modification to the procedural schedule:

February, 23 2021	March 1, 2021	Last day to request discovery
February 23, 2021	March 1, 2021	Parties file issues list, order of witnesses, and Order of cross-examination
February 26, 2021	March 5, 2021	Parties file position statements
March 11, 2021	March 11, 2021	Beginning of two-day evidentiary hearing
April 8, 2021	April 8, 2021	Post-hearing briefs
April 16, 2021	April 16, 2021	Reply briefs

6. The OPC has contacted all parties to this case regarding this proposed modification to the procedural schedule, and each party has represented that it does not object.

WHEREFORE, the Office of the Public Counsel respectfully requests the Commission issue an order modifying the procedural schedule for this case as set forth herein.
