**STATUS REPORT**

Pursuant to the Missouri Public Service Commission’s Order dated May 5, 2022, Symmetry respectfully states the following:

On December 8, 2021, this Commission entered its Order Setting a Procedural Schedule. On March 21-22, 2022, Symmetry Energy Solutions, LLC, The Empire District Gas Company d/b/a Liberty Utilities or Liberty, the Office of Public Counsel and the Staff of the Missouri Public Service Commission (collectively, “the Parties”), participated in a Settlement Conference and reached a settlement in principle to resolve this matter. On March 31, 2022, the Parties filed a Unanimous Joint Motion to Amend Certain Deadlines in the December 8, 2021 Order Setting a Procedural Schedule and Proposed Order Adopting the Amended Schedule. Since that date, the Parties have negotiated diligently and in good faith to reach a resolution in this matter. On May 5, 2021, the Commission ordered Symmetry to file a Status Report.

The Parties have agreed to the material terms of a stipulation and agreement and are close to finalizing that agreement. Symmetry respectfully requests that the Commission direct the Parties to either file a stipulation and agreement or an additional status report no later than May 16, 2022.

**WHEREFORE**, the Symmetry respectfully requests that this Commission order the Parties to either file a stipulation and agreement or an additional status report no later than May 16, 2022.
