SECOND ORDER DIRECTING FILING

The order approving the stipulation and agreement which the Missouri Public Service Commission (Commission) entered on July 6, 1999, stated, inter alia, that after the sale of House Springs Sewer Company, the company should pay all assessments and that the Staff of the Commission should dismiss its complaint after the payment.
