**SECOND ORDER DIRECTING FILING**

The order approving the stipulation and agreement which the Missouri Public Service Commission (Commission) entered on July 6, 1999, stated, *inter alia*, that after the sale of House Springs Sewer Company, the company should pay all assessments and that the Staff of the Commission should dismiss its complaint after the payment. On September 22, 2000, the Staff filed its report on the status of the case which stated, *inter alia*, that the Respondent "...is currently operating under the terms of a Court approved consent decree...and one of the decree's terms is that [the Respondent] shall be sold no later than December 31, 2000."

Staff will be directed to file a report on the status of this case.

**IT IS THEREFORE ORDERED:**

1. That the Staff of the Missouri Public Service Commission shall, no later than February 8, 2001, file with the Commission a report on the status of this case.

2. That this order shall become effective on January 19, 2001.

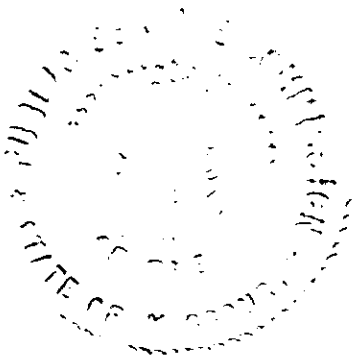
