COME NOW the Staff of the Missouri Public Service Commission ("Staff") and Union Electric Company d/b/a Ameren Missouri ("Company" or "Ameren Missouri") and request an amendment to the procedural schedule set by the Commission in its September 28, 2022, *Order Setting Procedural Schedule and Adopting Test Year* ("Procedural Order") and, in support of their joint request, state as follow:

1. The Procedural Order calls for a technical conference on February 9, 2023. The Commission has scheduled two Local Public Hearings in the St. Louis area on that same date, making it impractical to hold the technical conference, the primary purpose of which was for the Company and Staff, in particular, to discuss errors or other discrepancies between their revenue requirements.

2. The Company and Staff conferred and do not believe this technical conference is necessary given that the Company and Staff have already had multiple meetings since the filing of Staff's revenue requirement on January 10, 2023 to discuss such matters. The Company and Staff have agreed that they can have, as necessary, additional ad hoc meetings if necessary. For these reasons, the Company and Staff request that the Commission delete this technical conference from the procedural schedule.

3. The Company and Staff have conferred with counsel for all other parties to this docket, each of whom have indicated that they do not oppose this request.
