REQUEST FOR CLARIFICATION

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or the "Company"), and submits this *Request for Clarification* ("*Request*") of the Missouri Public Service Commission's ("Commission") *Order Approving Compliance Tariff with Expedited Effective Date* ("*Order*") issued January 21, 2020. In support of its *Request*, the Company respectfully states as follows:

- 1. On January 21, 2020, the Commission issued its *Order*, which approved the Company's compliance tariffs implementing Rider EEIC with an effective date of February 1, 2020. Rider EEIC was the subject of an *Initial Stipulation and Agreement* ("*Initial Stipulation*") entered into by the Company and the Commission's Staff ("Staff") and approved by the Commission on January 15, 2020.
- 2. Upon preparing for implementation, Ameren Missouri noted that one tariff sheet filed on November 22, 2019 requires an earlier implementation date. Specifically, Tariff Sheet No. 91.22 needs an implementation date no later than January 27, 2020 so that the shift from billing month to calendar month noted therein can be appropriately implemented. Because Tariff Sheet No. 91.22 did not require re-filing to make corrections¹ or to effectuate the settlement,² Ameren Missouri requests clarification that Tariff Sheet No. 91.22 may become effective as of January 27, 2020.

3. Ameren Missouri has consulted with both Staff and the Office of the Public Counsel, and has confirmed that both agree Tariff Sheet 91.22 may become effective no later than January 27, 2020.

WHEREFORE, Ameren Missouri respectfully requests that the Commission clarify that Tariff Sheet No. 91.22 may have an effective date of January 27, 2020.
