Re: Notice of Automatic Conversion of Local Franchise to State Video Service

Authorization

To Whom It May Concern:

Pursuant to RS Mo. § 67.2679.9, Poplar Bluff Municipal Utilities ("the Company") hereby provides notice of an automatic conversion of its local cable franchise with the City of Poplar Bluff into a state Video Service Authorization ("VSA"), effective upon the date of this notice.

State law provides:

Any person providing video service under a franchise, franchise extension or expired franchise or ordinance previously granted by a franchise entity may, at its option ... [a]utomatically convert the franchise, franchise extension, or expired franchise in a political subdivision into a state-issued video service authorization, any time after a video service provider other than an incumbent cable operator obtains a video service authorization for such political subdivision, provided that notice of the automatic conversion to the public service commission and the affected political subdivision is made and upon compliance with the provisions of sections 67.2675 to 67.2714.

RS Mo. § 67.2679.9.

The law thus provides for an automatic conversion of a local franchise into a VSA any time after a non-incumbent video service provider obtains a VSA for the affected political subdivision, provided notice is given to the Public Service Commission and the affected subdivision. The affected political subdivision is the City of Poplar Bluff, which granted a local franchise to the Company on February 20, 2001.

The Public Service Commission granted a VSA to Boycom Cablevision, Inc. ("Boycom"), for the City of Poplar Bluff on May 11, 2011, see In the Matter of the Application

of Boycom Cablevision, Inc., for Video Service Authorization, File No. KA-2011-0348 (May 11, 2011). Boycom is not an "incumbent cable operator," as that term is defined by statute. State law defines an "incumbent cable operator" as "the cable service provider serving cable subscribers in a particular franchise area on September 1, 2007." RS Mo. § 67.2677.8. Because Boycom was not serving cable subscribers in the City of Poplar Bluff on or prior to September 1, 2007, it is not an incumbent cable operator for that political subdivision.

Therefore, under state law, the Company need only provide notice of automatic conversion to the Public Service Commission and to the affected political subdivision, the City of Poplar Bluff, for the conversion of the local franchise into a state VSA to be effective. This letter, and the formal notice attached hereto, constitutes such notice. The law does not require state or local approval for an automatic conversion. The Company will pay the City of Poplar Bluff a franchise fee of 5%, as authorized by RS Mo. § 67.2689, and comply with applicable state law.

As a courtesy, and for your records, the Company encloses a formal notification of automatic conversion, which we provide to assist the Commission in its recordkeeping. We consider the automatic conversion to be effective upon the date of this notice, as provided by law.
