ORDER SETTING BRIEFING SCHEDULE, SETTING TIME FOR FILING OF POST-HEARING EXHIBITS, AND SETTING TIME FOR FILING OF RESPONSES

This order sets the briefing schedule, directs the filing of post-hearing exhibits, and sets the time for responses to post-hearing exhibits.

A hearing was held in this matter on September 24-27, 2001. On the last day of hearing, the parties agreed to the briefing schedule set out below. In addition, the Commission requested that a post-hearing exhibit be filed by Southwestern Bell Telephone Company. The Commission will set the time for filing of that exhibit and for the filing of responses regarding that exhibit.

The Commission also received written motions from Fidelity Communication Services III, Inc., Missouri Independent Telephone Group, and IP Communications Corporation d/b/a IP Communications of the Southwest requesting to be excused from the hearing. Each of those parties waived their rights to presentation of an opening statement and the right to cross-examination, but each requested that it be allowed to file briefs. The motions were granted in that the movants were not required to be physically present at the hearing; however, the Commission notes that by failing to be present at the hearing, the

parties waived any rights to present arguments or evidence and waived any rights to object to the arguments and evidence presented by the other parties.

The Commission also received on September 18, 2001, the Petition of Morton Posner for Leave to Appear on Behalf of Allegiance Telecom pursuant to Commission rule 4 CSR 240-2.040(3)(C). Mr. Posner's petition was in compliance with the Commission's rule and was granted at the hearing.

The Commission received the motion of Mpower Communications Central Corp., f/k/a Primary Network Communications, Inc., f/k/a BroadSpan Communications, Inc., requesting that it be allowed to withdraw from the case. Mpower stated that it had ceased operations in Missouri and has surrendered its certificate of authority. The motion was granted at the hearing and Mpower is dismissed as a party to this case.

IT IS THEREFORE ORDERED:

1. That the following schedule for briefs, filing of post-hearing exhibits, and responses to post-hearing exhibits shall be followed:

Objections or responses to Exhibit 29 due	October 16, 2001

2. That the Motion to Withdraw From Case of Mpower Communications Central Corp., f/k/a Primary Network Communications, Inc., f/k/a BroadSpan Communications, Inc., is granted. Mpower shall be removed from the official service list of this case.

- 3. That the requests of Fidelity Communication Services III, Inc., Missouri Independent Telephone Group, and IP Communications Corporation d/b/a IP Communications of the Southwest to be excused from the hearing are granted.
- 4. That the Petition of Morton Posner for Leave to Appear on Behalf of Allegiance Telecom is granted. The Commission's Data Center shall add Mr. Posner as counsel for Allegiance on its official service list.
 - 5. That this order shall become effective on October 9, 2001.
