customers in the Missouri service area of
the Company.

SECOND SUSPENSION ORDER

On October 15, 1981, Union Electric Company of St. Louis, Missouri,
submitted to this Commission tariffs to comply with 4 CSR 240-20.060, the Commis-
sion's rule on cogeneration. The proposed tariffs were suspended by order of the
Commission on December 3, 1981, to April 14, 1982, unless otherwise ordered by
this Commission.

The Commission has determined that the tariffs should be further
suspended for a period of six months, unless otherwise ordered by the Commission.

It is, therefore,

ORDERED: 1. That all tariff sheets submitted on October 15, 1981, by
Union Electric Company of St. Louis, Missouri, for compliance with
4 CSR 240-20.060 for customers in the Missouri service area of the Company be, and
the same are, hereby further suspended for a period of six (6) months beyond
April 14, 1982, to October 14, 1982, unless otherwise ordered by the Commission.

ORDERED: 2. That this order shall become effective on the date hereof.
