Sierra Club supports its Motion for Leave to Late File its Initial Post-Hearing Brief as follows:

1. Initial Post-Hearing Briefs in this proceeding were due on May 5, 2023.
2. On May 5, 2023, Sierra Club filed confidential and public versions of its Initial Post-Hearing Brief through the EFIS system. But because of an error in the confidential protection of the confidential version, Sierra Club asked the PSC helpdesk to delete the filing. Sierra Club consulted with Commission personnel after business hours on Friday evening and appreciates their prompt attention and assistance.
